Each student intern or veteran fellowship assignment will involve a set of customized learning objectives and deliverables that provide hands-on experience assisting with and accomplishing specific work tasks or projects within each section.

#### **Student Internship Candidates**

Current enrollment in a college degree program or registration for full-time or part-time classes for the Fall, 2018 quarter/semester, or authorization to register for the Fall, 2018 quarter/semester (if registration has not yet occurred), or full-time or part-time class status for the summer is required.

#### **Veteran Fellow Candidates**

#### Customer Communications and Services (CCS) – Marketing and Promotions – Undergrad, Graduate or Vet Fellow opportunity available Summer 2018 through Spring 2019

Under the guidance and mentorship of a professional marketing staff, the selected Intern/Vet Fellow will gain hands-on experience by assisting in the development and execution of marketing and promotional campaigns for the nation's 6th largest transit agency (in terms of daily ridership). Interns/Vet Fellows will design and apply creative approaches for messaging to targeted, diverse audiences. Will assist with varied forms of outreach such as direct mail, web, paid media, events, and social media. Will write copy for multiple formats such as marketing materials, social media, and reports. Will assist with creating visual communication pieces using tools of graphic design, layout, infographics for print and web. Will assist with development and implementing social marketing and other strategies to inform and influence travel behavior. Will use evaluation tools to assess market penetration such as surveys and social media analytics. Will work with professionals from different disciplines within and outside Metro, including staff from local jurisdictions (cities), non-profits and outside vendors such as copywriters, graphic designers, and direct mail and fulfillment houses.

Specific learning objectives will include:

- Creating and executing strategic marketing tactics
- Planning and developing social media content
- Copywriting and graphic design coordination
- Learning how public outreach is done

Specifically, this intern will look at how the Design and Construction contributes to King County Metro Transit's organizational goals. Selected student will gain a better understanding of the complexity and variety of projects completed within Transit and King County and gain a deeper appreciation for what it means to be a public employee at a transit agency. This assignment will provide opportunities to evaluate policies, procedures and practices with an equity lense, identify barriers and engage in conversations with peers, section management and senior management regarding information learned. The student selected for this assignment will be provided the opportunity shadow individuals within government and get a better idea of the cross-agency relationships needed to successfully implement capital programs/projects. Transportation Demand Management (TDM)

This internship opportunity focuses on transportation demand management (TDM). The Market Development group is a regional and national leader in the field of transportation demand management (TDM), particularly through its work with local cities, employers, developers and other partners. The group implements programs to reduce drive-alone travel, develops alternative transportation and mobility products, applies innovative pricing and financial partnering approaches, proposes transit/rideshare-supportive policies and legislation at the local and state levels, and manages agreements with employer agency and local jurisdictional partners.

The individual selected for this assignment should expect to learn about the principles of Transportation Demand Management and the role of TDM in the overall transportation system. Additionally the selected candidate will gain hands-on experience in the implementation of TDM programs.

Specific emphasis includes:

- Gaining knowledge of approaches to implement community based programs;
- Developing knowledge of community based outreach as tools to influence travel behavior;
- Gaining a good understanding of inter-agency partnership work, through interaction with consultants, staff at non-profit agencies and jurisdictions; and

The team develops pilots, programs and technical planning work to better manage existing transit parking, identify low-cost options for expanding parking capacity in the near term, plan for longer-term permanent parking expansion, and support non-drive alone options for reaching the transit system.
