What is SLS?

SLS provides a safe and confidential space for UW-Seattle students who may have legal questions and/or concerns. As a law office, SLS staff must abide by the Rules of Professional Conduct, which includes keeping all information provided by all clients confidential.

We are proud to work with and for all UW-Seattle undergraduate, graduate, and professional students regardless of race, ethnicity, age, religion, (dis)abilities, gender identity, sexual orientation, class, or citizenship status.

IS THERE A COST?

The initial 40 minute consultation is free. Students receive unlimited free consultations as long as the issues or parties are unrelated.

For ongoing representation, SLS bills most matters at \$20 per hour. Students with extreme financial hardship may apply for a fee waiver or reduction of the hourly rate.

How We Can Help

Students seek assistance from SLS for issues such as:

- Landlord/Tenant
- Discrimination
- Immigration
- Protection orders
- Name and gender marker changes
- Estate planning (wills, powers of attorney, healthcare directives)
- Criminal and traffic
